 - I undertake to pay the following fees:
 - For the storage of technical documentation - a fee of PLN 120 + VAT at the rate in force on the day of issuing the VAT invoice, for each declared year of manufacturing - the fee is collected in advance for the whole period and is not refundable in case of discontinuation of manufacturing earlier than in the declared period or in case of withdrawal of the certificate.
 - For storing the technical documentation for a period of 10 years after the end of manufacturing - a one-off fee of PLN 1200 + VAT at the rate applicable on the day of issuing the VAT invoice.
 - For the extension of the certificate - one-off fee for each extension in the amount of PLN 200 + VAT as applicable on the day of issuing the VAT invoice.
 - For the extension of the validity of the certificate - a fee of PLN 200 + VAT at the rate applicable on the day of issuing the VAT invoice, for each declared year of the extension.
- The above fees are payable in advance. The charge invoice will be issued by ITG KOMAG on the basis of the work acceptance protocol.

- (a) a general description of the product,
- (b) conceptual design and manufacturing drawings and schemes of components, sub-assemblies, circuits, etc.,
- (c) descriptions and explanations necessary for the understanding of those drawings and schemes and the operation of the product,
- (d) a list of the harmonised standards applied in full or in part the references of which have been published in the Official Journal of the European Union and, where those harmonised standards have not been applied, descriptions of the solutions adopted to meet the essential health and safety requirements of this Directive, including a list of other relevant technical specifications applied. In the event of partly applied harmonised standards, the technical documentation shall specify the parts which have been applied,
- (e) results of design calculations made, examinations carried out, etc., and
- (f) test reports.
